A meeting of the Waterloo Town Council was held on April 9, 2019 at 6:02pm at the Waterloo/Grant Twp. Public Library. Members present were:

The following business was discussed and action taken: Unless specified all votes were unanimous.

Communications from the President:

- So far we have received \$37,800.00 from donations towards Veterans Park

Communications from Committees/Council Reports:

Communications from the Town Manager:

- Council approved allocation of \$2156.00 from the Skate Park Fund to Veterans Park
- Duke Williams has requested the Town find a new Cemetery Sexton. The Cemetery Board would like the Town to go ahead and advertise for said position

Public Hearing:

- The Council waved 2nd reading and adopted Ordinance 19-01, Update to Sewer Use and separating Water Use Ordinance into separate chapters
- The Council waved 2nd reading and adopted Ordinance 19-02, continuing Cumulative Fire Fund

New business:

1. March minutes and claims were approved
2. Council approves the hiring of Mike Ford for seasonal mowing. He'll start Thursday 4/11/19
3. Council approved for the Water/Sewer Dept to purchase the Street Dept's 1992 International in the amount of \$6,000.00
4. Council approved the Dekalb County Interlocal agreement with minor changes to the language
5. CoCiGIS agreement was tabled
6. Council gave authorization for David Bolton, council president, to sign the contract renewal with Baker Tilly (formerly Umbaugh)
7. Council approved Wessler consultant contract for Enforcement Response Plan
8. Council decided that instead of changing parking on Maple St. by the Library, they asked David Wolfe, Street Super. to have some signs placed in the Town Hall parking lot designating a couple spots for Library employees.
9. Council discussed some changes they would like to make to the Town's Personnel Policy. David Kruse, Town Attorney is going to re-work things for a resolution. Item was tabled for next month.




The Waterloo Utilities Departments has agreed to purchase the 1992 International dump truck from the Waterloo Street Department for the trade in price of \$6,000.
