A meeting of the Waterloo Town council was held October 24, 2022, at 6:00p.m. at the Waterloo Historic Train Depot present were:

The following business was discussed, and action taken: Unless specified all votes were unanimous.

Public Hearing:

1. Budget:

Hearing opened at 6:02 p.m.

Jessup stated this is the second review of the budget. Jessup asked for comments from the council. It is a total budget of \$2,047,828 of that \$1,504,000 is part of the tax levy. There are no comments from the council. Jessup asked for public comment. There were none. Motion to approve the Ordinance 22-08 for appropriations and tax rates made by Hobbs (Caudill) passed.

Jessup thanked everyone for their hard work on the budget.

Public Hearing:

2. URT Tax:

Hearing opened 6:05 pm

Jessup explained this resolution is due to the elimination of the URT tax due to IC6-2.3. Jessup reads Resolution 22-05. Discussion of the tax and rate structure was held. Hobbs would like a statement to the public making it clear why this was done. Jessup asked for public comment. There was none. Motion to approve the URT Tax Resolution 22-05 made by Caudill (Surber) passed.

3. Trash Ordinance:

Jessup explained the Trash Ordinance needed to be revised to come into compliance with the State Board of Accounts. The rates were not listed and some of the information was outdated. Changes and revisions were reviewed. Jessup asked for questions. Surber made sure that the Concord Park Mobile Home Park was not part of the contract. Duszynski stated they are not. Surber is concerned about the verbiage stating all entities would be billed. Hobbs said since they do not receive the service it would not cause them to be billed. Duszynski stated Knoll Creek is the same. Jessup stated the situation in which those entities have been grand-fathered in will need to be looked at and addressed. Discussion was held. Hobbs suggested passing this now and dealing with it at needed. No public comment. Motion to approve Trash Ordinance 22-07 made by Hobbs (Iddings) passed.
Hearing closed at 6:31 pm


Jessup stated there is a lot going on in email and to keep updated. Caudill asked when the benefit package will be ready. Duszynski and Howard are working on it.
