If you want your hero included in the memorial publication, attach a type-written biographical sketch including name, rank, years of service, and any personal information or anecdotes you would like to share. Maximum 500 words. Biographical sketches will be edited before final publication.

The purchaser will receive an email when photos can be picked up. The banner will belong to the purchaser. The purchaser will be notified to pick up their banner at a designated place at the end of the season.

Banner location will be determined by receipt of order and payment. There are a limited number of poles available. Orders received over that number, or after the submission deadline, will be saved for the 2025 round.
